# **Community Services**

Papatakohe Playground



Last Sunday, a member of the public alerted us to a small sinkhole near the barbecue area at Papatakohe Playground in Cambridge. By Monday, the sinkhole had grown and compromised some of the concrete around the barbecues.

We have fenced off the area and installed signage to let people know the barbecue area is temporarily closed while the ground surface is repaired. We expect this work to be completed today.

The playground is still within its defects period and staff are working alongside the playground installer and developers 3Ms to identify the cause of the sinkhole.

### SH3 tree works

Scheduled tree maintenance will be under way on the western side of Ōhaupō Road (SH3) between Racecourse Road and Greenhill Drive from Monday, August 18 (weather permitting).

Our contractor, Treescape, is expecting it will take three days to complete the work, which includes inspecting and pruning council trees, along with removing hazards, weeds, and clearing any obstructions to our roadside mowing contractor.

Traffic management will be in place including shoulder closures and contraflows as required. No lane Document Set 15:468460 traffic are expected.

# **Growth and Regulatory Services**

Cambridge to Piarere (C2P) State Highway 1 realignment



A decision on the fast track application for NZ Transport Agency Waka Kotahi's Cambridge to Piarere SH1 realignment is expected after Monday, August 25.

NZTA has sought consents from Waikato Regional Council, Waipā District Council and Matamata Piako District Council.

We lodged a submission in support of the proposal with the Environmental Protection Authority which included recommended amendments to NZTA's proposed designation conditions.

The Expert Consenting Panel that will determine the consents is considering all submissions and additional information provided by NZTA, and has confirmed that no hearing is required. There is no set date for the decision, but it will be no sooner than August 25.

### **Fast-track approvals**

Waipā District Council has been invited by the Environmental Protection Authority to comment on two referral applications under the Fast-track Approvals Act 2024, which streamlines approvals for nationally and regionally significant projects.

- Rogerson Block, 183 & 293 Tuhikaramea Road, Hamilton comments due Thursday, August 21. The
  proposal is for residential and industrial development on 40ha of Rural Zone land.
- Harlow Lifestyle Village, 2025 Ōhaupō Road, Te Awamutu comments due Friday, August 29. This
  project is to construct a residential and lifestyle village on 25.7ha of Rural Zone land. A private plan
  change for the same project has been on hold since April 2023.

#### About the fast-track process:

The Act creates a "one-stop-shop" for resource consents, notices of requirement, and certificates of compliances under the RMA, and approvals required under many other pieces of legislation. Under the fast-track pathway, expert panels consider approvals as a single package. Applicants must first submit a pre-substantive (referral) application, which includes consultation with relevant local authorities.

### Wasteworx Cambridge Road operation

Council staff made a site visit to Wasteworx's Cambridge Road operation on Tuesday, August 5. No issues were identified, and the site manager confirmed his plans to meet directly with neighbours.

All pre-operation consent requirements have been met, except for the updated Noise Management Plan (NMP), which was received on Thursday, August 7 and is under review by Environmental Health staff.

The main noise issue was from the concrete crusher, and interim approval was granted to operate without the crusher until the NMP is approved.

Council staff have been responsive to concerns, including following up the complaint received in late July about site activity and "rubbish" storage. Wasteworx advised all material is being recycled.

While some complainants feel the operator "isn't listening," our staff report Wasteworx is responsive to emails and queries.


Staff continue to monitor the site and ensure compliance with Industrial Zone rules and consent conditions.

Note: asbestos is prohibited on site under Worksafe regulations. Any detected asbestos will be separated, traced to the source, and followed up in line with these regulations.

# Information requests


The following is a summary of the information requests received by Council that are processed under the Local Government Official Information and Meetings Act 1987 (LGOIMA) or the Privacy Act 2020.


Council received a total of 452 information requests during the 2024/25 financial year. This continues an upward trend in the number of requests coming into Council each year.

Breakdown of the types of information requests received:





Council responded to 451 of these information requests within the legislated timeframe of 20 working days. The one response that was sent out late was due to the information request being received via mail and the request not being identified as a LGOIMA until near the end of the 20-working day timeframe. Once identified this was responded to promptly.

Council can set charges in responding to LGOIMA requests where there is substantial collation or research required. We set charges as part of the response for 10 information requests over the 24/25 financial year. Only one of these charges was paid, the other charges were not paid for the following reasons:

- · The requester refined the request to make it manageable; or
- There was no response from the requester, so request was closed; or
- · On review the charge was remitted.

### **Ombudsman Investigations Summary**

Over the 24/25 financial year Council was subject to four Ombudsman investigations:

- One related to a LGOIMA charge closed Council released some information, and our charge was
  upheld for the remainder of the request.
- One related to a LGOIMA response closed Council found to have acted reasonably.
- Two non-LGOIMA investigations relating to rates complaints both closed Council found to have acted reasonably in both instances.

There are no outstanding Ombudsman investigations.

# **Service delivery**

### Southern Wastewater Treatment Plant

We are continuing to work closely with Hamilton City Council (HCC), the lead council for the Southern Wastewater Treatment Plant project. HCC staff advise that the project team has been proactively communicating with local residents in the area around the proposed site, a parcel of HCC-owned land in Waipā, on 131 Raynes Road.

This project is in its early stages, and as such some of the information requested including detailed timelines and technological information, is not yet available.

The new HCC and Waikato District Council-Controlled Organisation IAWAI will take ownership of the project from July 1, 2026. Currently, HCC has funding for project planning, which includes plant design, site master planning, discharge options and consenting. The construction of the plant is not yet funded and is likely several years away.

Throughout the design phase, all potential impacts on neighbouring properties will be investigated, and mitigations will be developed (where required) – the project team will continue to engage affected residents in due course.

As indicated to the local community, the site selection process for this project was extensive and rigorous, and considered a wide range of technical factors, ultimately leading to 131 Raynes Rd being the preferred site. HCC won't be exploring any other potential sites for the project.

We are aware that some residents have concerns about the project and HCC have been in regular contact with some individuals to provide information and hear their concerns, and will continue sharing information with the community as they progress with technical investigations and design.

Preparations are underway for a community open day to provide more details about the project, including a timeline of the engagement process, and examples of what modern treatment plants look like. This will take place later this year and will provide an opportunity for community members to meet with the project team and ask any questions and/or share any concerns they may have.
