## **Community Services**

Te Awamutu Cemetery works



We are creating 24 new car parks at Te Awamutu Cemetery and remarking the existing carpark, with the work starting next week due to the contractor being available earlier than anticipated. This means more space for visitors, easier access, and the ability to park closer to the far side of the cemetery — making visits more convenient for everyone. We will also be adding a new soil stockpile area to help our team maintain the cemetery more efficiently and keep the grounds tidy. The new carpark and the soil stockpile will be located near the toilet block.

This project was identified in Waipā District Council's Cemetery Concept Plan, which was finalised in June 2023 to help maximise existing cemetery capacity. The upgrades were included and budgeted for in the approved 2025-34 Long Term Plan.

Construction for this project will start on Monday, September 1 and is expected to take 10 weeks to complete.

During this time, the cemetery will remain open, and our contractors will be working with funeral directors and our sextons to ensure that work and noise are ceased or minimised during funeral services.

The first funding round for the 2025/26 Creative Communities Scheme opens on Monday, September 1.

Each year, Council works with Creative New Zealand to support community arts and cultural projects that bring people together and encourage participation in creativity across Waipā. Projects could be anything from performances, workshops and exhibitions to festivals or something completely unique.

Creative New Zealand provides funding for councils to distribute.

There are two funding rounds each financial year, with grants usually between \$500 and \$5000. Around \$56,500 will be allocated this year across both rounds.

Funding is open to groups, organisations and individuals that meet the criteria. Past projects have included murals, music workshops, film festivals and pottery exhibitions.

More details, including how to apply, are available on Council's website.

Housebound library service

This information is provided from Waipa District Council For more than 20 years, Waipa District Libraries have offered a free Housebound Service – delivering not just books, but connection, directly to people's homes.

The service is not widely known though, and library staff are keen to see more people benefit – and more volunteers involved. While it mainly serves town residents, rural applications may be considered depending on delivery capacity.

The service ensures anyone unable to visit in person – whether due to injury, mobility challenges, age, or even new parenthood – can still access the library's full range of resources, including DVDs, puzzles and items from the *Library of Thinas*.

- In Te Awamutu, the service is run by local volunteers who even cover their own fuel costs.
- In Cambridge, deliveries are handled by library staff, including visits to retirement villages and dementia care units

### John Kerkhoff Park field renovations

Our Park Operations team are working closely with the Cambridge Football Club to renovate the two sand carpet fields installed over the 2022/23 summer, with work starting next week.

The renovations are planned and budgeted for as part of the maintenance required to keep these fields operating appropriately, and include removing debris, adding sand to maintain drainage functions, reseeding and fertilising.

The fields will be closed to the public for around six weeks, while the new growth establishes.

At the same time, the Cambridge Football Club are undertaking maintenance on the other fields along with lighting improvement.

# Service delivery

## Road cone hotline



Since the Minister of Transport's road cone hotline opened in June, Council has received four referrals. Each has been investigated, with the following outcomes:

#### June 13 – Kaipaki/Lamb/Cambridge Rd intersection

Concern: Excessive cones during Fieldays.

Finding: Cones were appropriate to manage heavy traffic and park-and-ride buses. No changes needed.

#### June 19 (received June 24) – Cambridge Rd. Cambridge

Concern: Excessive cones at major construction site.

Finding: Cones were appropriate given complex traffic management (roundabout, underpasses, new development). No changes needed.

#### August 6 – Kaipaki Rd

Concern: Too many cones for short-term works.

Finding: Cones were necessary for safety, but fewer should have been left out overnight. Feedback was provided to the contractor.

#### August 8 – Mutu St, Te Awamutu

Concern: Excessive cones at site not found.

Finding: Coordinates did not match any works. Caller likely entered incorrect information, so no action was possible.

Council investigates every tip, takes action where required, and reports back to WorkSafe. Our role is to check that traffic management is safe and appropriate — we don't count cones or track numbers of cones removed.

### Te Awamutu Transfer Station

As advised by Steph earlier this month, for some time we have been aware that the landowner of the waste transfer station in Daphne Street, Te Awamutu was not renewing the operating lease with Waste Management Ltd. This raised concerns in the community about the possibility of the town being left without a transfer station.

We are pleased to update you that the landowner has entered into a lease arrangement with a new operator, Evolve Ventures Ltd. The site will continue to operate as a resource recovery centre and transfer station, with operations beginning on Monday, September 1. We will update the information on our Wasteless Waipā website on Monday to reflect the change.

While Evolve Ventures Ltd also provides services under Council's kerbside recycling contract, please note that the transfer station is a separate commercial operation and Council is not directly involved in its management.

# **Economic development**

Infometrics has released its <u>June 2025 Quarterly Monitor</u>, with results showing Waipā is holding steady in some challenging times.

- **GDP:** Waipā's economy contracted just 0.2 percent over the past year, better than the national decline of 0.8 percent and slightly ahead of the wider Waikato (0.3 percent). Stronger performance in the primary sector and manufacturing helped offset a slowdown in construction and utilities.
- Spending: Consumer spending in Waipā grew 0.4 percent over the year, bucking the regional (-0.8 percent) and national (-1.7 percent) declines. A stable local labour market and a strong Fieldays helped lift results.
- Jobs: While some jobs were lost in construction, accommodation and retail, growth came through in
  education, healthcare (with new lifestyle villages opening) and food and beverage manufacturing.
- Affordability: Another positive sign is that household incomes rose 3.3 percent, outpacing house price growth. This saw affordability improve from a peak of 7.3 percent in 2024 to 6 percent this quarter. Rent affordability, at 24.5 percent, has also improved to its best level since March 2024.
- Building activity: Both residential consents (up 17.7 percent) and non-residential consents (up 58.3 percent) have increased for the year to June, suggesting pressure easing on the construction sector.
   New housing, industrial and commercial developments are visible across Cambridge and Te Awamutu, with tradies and suppliers keeping busy.

While economic conditions remain tough, Waipā's diverse economy and strong community spending are positive signs. The below infograph provides a great snapshot of how Waipā is faring in these challenging times.

# **Planning**

Private Plan Change 35 – Te Awamutu Large Format Retail Centre

A private plan change request has been lodged which relates to the existing Large Format Retail Centre at 670 Cambridge Road in Te Awamutu. The request seeks to rezone land at 638 Cambridge Road, which adjoins the centre, to Commercial Zone and to relocate the existing Mitre 10 onto this site. The existing Mitre 10 building within the centre will be available for repurposing for new commercial activities (including retail tenancies 400m2 or larger).

### In brief updates

- **Proposed Waste to Energy Plant, Te Awamutu.** At this stage there is no further update on the payment of outstanding costs and resumption of processing the application by the EPA Board of Inquiry.
- Cambridge to Piarere (C2P) State Highway 1 realignment. We may receive the decision this week, but that's not confirmed.
- PC14 Environment Court mediation dates. Dates have not yet been set on the three appeals.

### **Newcombe Road Quarry**

Independent hearing commissioners have granted resource consent for the proposed sand quarry at 77 Newcombe Road, Cambridge, following a joint hearing with Waikato Regional Council. The commissioners considered both district and regional matters in a combined decision.

The quarry will extract up to 400,000 tonnes of sand per year for around 25 years, operating weekdays 7am–5pm and Saturdays 7am–12pm. At peak, up to 200 truck movements per day are expected, with typical daily movements closer to 78.

Under the Resource Management Act, consent could only be refused if effects could not be sufficiently avoided, remedied, or mitigated.

This information in particular with the Wall with the Complication of their respective conditions. Both councils will monitor compliance of their respective conditions of consent.

Council received 350 submissions, mostly opposed. The independent hearing commissioners considered this feedback alongside technical evidence to ensure a balanced decision. A public media release with FAQs will follow and be available with the decision on the Council website on the afternoon of Tuesday, August 26.

#### Key Messages

- The decision on the quarry was made independently under the Resource Management Act, not by councillors, after a joint hearing with Waikato Regional Council.
- While many in the community opposed the proposal, the independent hearing commissioners could only decline if effects could not be managed.
- More than 350 submissions (mostly opposed) were carefully considered by the independent hearing commissioners, alongside technical evidence.
- The RMA framework required the commissioners to approve if effects could be sufficiently avoided, remedied, or mitigated.
- Consent has been granted with strict, enforceable conditions to protect the community and environment, with ongoing monitoring by both councils.
- The conditions cover truck movements, dust, noise, water quality, and site rehabilitation.
- Compliance will be closely monitored; breaches can lead to enforcement action, fines, or prosecution.
- At peak, there will be up to 200 truck movements a day, though typical daily numbers are closer to
   78. More than half of these are expected to travel to and from the site from the south.
- Quarry operations are weekdays 7am-5pm, and Saturdays 7am-12pm.
- The quarry cannot operate until consent conditions are met, and apply for the duration of the
  consent.
- The decision can be appealed to the Environment Court within 15 working days by the applicant or submitters.

## Sustainability and Climate Change
